GENE

RAL RULES

1. This is a Standard Flower Show staged according to the standards of the National Garden Clubs, Inc.
2. Design and Special Exhibits classes are open to members of the 9th District, FGCNYS, Inc. Horticulture classes are open to any amateur grower except for Section L., Classes 53-56 and Section M., Classes 57-60 which are open only to members of the Federated Garden Clubs of NY State, Inc..
3. All entries must be checked for conformance to the schedule by the applicable Classification Chairman. Entry cards must be initialed before the exhibitor leaves the exhibiting area.
4. See specific Division rules for entry times.
5. All exhibits must be removed promptly at 3 pm on Sunday, September 18, 2016.
6. Judging will begin at 11 am on Friday, September 16, 2016. Only the Flower Show Chairman, Classification Chairmen and Judges' Clerks will be permitted in the exhibition rooms after entry times and during judging.
7. The NGC Standard System of Awards will be used for all competitive judging. Awards may be withheld if not merited. The judges are requested to award 90+ scores to non-blue ribbon winners where merited. The decisions of the judges are final.

8. Plants named on the New York State "Protected Native Plants" list cannot be exhibited in competitive classes. List is found at <http://www.dec.ny.gov> . Commercially developed cultivars (NOT NATURAL VARIETIES) of plants on the NY list are permitted ONLY when the DISTINGUISHING FEATURE is evident. The cultivar name must be listed on the entry card.
9. No artificial plant material is permitted in any Division. The emphasis of the show is on fresh plant material which may never be treated.
10. The 9th District and the Lasdon Park and Arboretum shall not be held responsible for loss or damage to persons or property.

DIVISION I – DESIGN

DESIGN RULES

1. Advance registration is required for all classes with applicable consultant for the Section.
2. Design entries may be entered on Thursday, September 15, 2016 from 2–6 pm and on Friday, September 16, 2016 from 8-10 am.
3. An exhibitor may enter as many classes as desired, but only one exhibit per class. Each entry must be the work of the one exhibitor whose name appears on the entry card.
4. Entry cards will be filled out and placed by the Design Classification Chairman. The exhibitor must list all plant material used in the design on the back of the entry card.
5. Some plant material must be used in every exhibit.
6. Fresh plant material may never be treated in any manner. Only dried plant material may be treated to alter its exterior appearance.
7. Plant material need not have been grown by the exhibitor.
8. No artificial flowers, foliage, fruits or vegetables are permitted.
9. Landscapes or scenes are not permitted.
10. Refer to the NGC Handbook for Flower Shows, page 189, for a list of what is permitted unless prohibited by the schedule, law or specific requirements of a Design Top Exhibitor Award.
11. If designer is unable to fulfill a registration, it is the responsibility of the designer to provide a substitute.

SECTION A.

The 1940s and the 1950s

Eligible for the **Table Artistry Award**
Designer's choice of fresh and/or dried plant material in all classes

Class 1. **"Drive-In Concession Stand"** 4 entries

Alfresco Exhibition Table Type II

Creative artistic arrangement of table components. Must not include a decorative unit but must include some plant material placed where needed to carry rhythm. Staged on black drums 19" high x 24.5" in diameter. Background wall is white brick. To be viewed from the front.

Class 2. **"Scrabble"** 4 entries

Functional Informal Table

Refreshments for two players. Decorative unit may be Traditional or Creative. Staged on a card table 32" high x 32" square and placed in the center of the room. Table cover required. To be viewed from the front and the back.

Class 3. **"Leave It to Beaver"** 4 entries

Functional Capsule Dinner Table

Traditional or Creative Table for one staged on a round Table 30" high and 30" in diameter covered with a white cloth provided by committee. Decorative unit appropriate to size of table. Background wall is cream. To be viewed from the front.

SECTION B.

The 1960s and the 1970s

Eligible for the **Petite Award**

Designer's choice of fresh and/or dried plant material in all classes

Class 4. **"The Twist"**

4 entries

Small Stretch Design

Creative Design not to exceed 8" in height, width or depth staged on a mantle 54" high. Background wall is cream. To be viewed from the front.

Class 5. **"A Chorus Line"**

4 entries

Miniature Line or Line-Mass Design

Traditional or Creative Design not to exceed 5" in height, width or depth staged on a recessed cream shelf 56" high x 12" deep. To be viewed from the front.

Class 6. **"First Walk on the Moon"**

4 entries

Small Plaque Design

Creative Design in low relief not to exceed 8" in height, width or diameter displayed on black easels supplied by committee and staged on a recessed cream shelf 43" high x 12" deep. To be viewed from the front.

SECTION C.

The 1980s and the 1990s

Eligible for the **Designer's Choice Award**
Designer's choice of fresh and or dried plant material in all classes

Class 7. **"Dolly the Cloned Sheep"**

4 entries

Mono-Botanic Design

A Creative Design using multiple parts of a plant or plants of one family or genus as the Designer chooses. Parts may be stems, blooms, foliage, roots, fruit, etc. Staged on Lucite pedestals 36" high x 18" square. Underlay which does not extend beyond the top permitted. Background wall is cream. To be viewed from the front.

Class 8. **"Totally Tubular"**

4 entries

Tubular Design

A Creative Design having a dominance of cylindrical components throughout. Tubes may be of metal, cardboard, plastic, plant material such as round stems, etc. May consist of more than one unit. Staged on black pedestals 40" high x 16" square. Background wall is cream. Underlay which does not extend beyond the top permitted. To be viewed from the front.

Class 9. **"Miami Vice"**

4 entries

Underwater Design

A Creative Design having components including some or all plant material submerged in water. Underwater components must contribute artistically to the overall design. Staged on black pedestals 40" high x 24" in diameter. Underlay which does not extend beyond the top permitted. Background wall is cream. To be viewed from the front.

National Garden Clubs, Inc. TOP EXHIBITOR AWARDS DESIGN DIVISION

DIVISION AWARD

AWARD OF DESIGN EXCELLENCE - Rosette of Gold Ribbons

One Award of Design Excellence is offered to the highest scoring exhibit in the entire Design Division entered by a single exhibitor, provided all General and Design Award Requirements are met. In sections where Top Exhibitor Awards have been placed, only those winners are eligible for consideration for the Award of Design Excellence.

SECTION AWARDS

General Requirements: Exhibit must be a blue-ribbon winner, either Traditional or Creative, scoring 95 or more in a Section with a minimum of three classes with at least four exhibits in each class as designated in the schedule. All General and Design Award Requirements must be met. Judges may withhold award if not merited.

DESIGNER'S CHOICE AWARD - Rosette of Purple Ribbons

One Designer's Choice Award is offered to the highest scoring exhibit in Section C., Classes 7-9. The exhibitor has complete freedom to choose plant material and other components for this award within NGC policies.

PETITE AWARD - Small Rosette of Blue and White Ribbons

One Petite Award is offered for the highest scoring exhibit in Section B., Classes 4-6.

TABLE ARTISTRY AWARD - Rosette of Purple Ribbons

One Table Artistry Award is offered to the highest scoring exhibit in Section A., Classes 1-3.

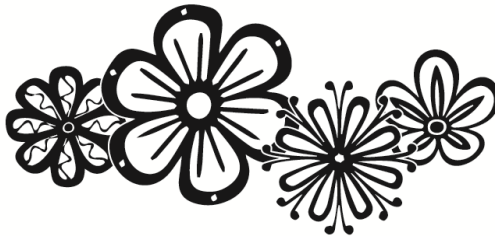
DESIGN DIVISION

Mabel A. Little Trophy for Miniature and Small Designs Rosette of Red and Purple Ribbons

Awarded to the miniature or small design which has won the NGC Petite Award in a District Standard Flower Show or the NGC Award of Design Excellence, if offered and awarded in a District Petite Standard Flower Show. It is accompanied by a silver tray which is to be held by the winner for one year and then returned to the Ninth District Awards Chairman.

May Ratchford Award Bronze Container from the Estate of May Ratchford

Awarded to a design in a District Standard Flower Show or a District Petite Standard Flower Show having won the Award of Design Excellence if offered or if not any of the following NGC Top Exhibitor Awards: Designer's Choice, Award of Distinction, Tricolor, Petite, Table Artistry or Holiday Excellence. In sections where a Top Exhibitor Award is not offered and the Award of Design Excellence is not given all designs scoring over 95 are eligible. The trophy is to be held for one year and then returned to the 9th District Awards Chairman.



DIVISION II – HORTICULTURE

HORTICULTURE RULES

1. All specimens must be fresh plant material grown by the exhibitor.
2. Cut specimens of annuals, biennials and perennials must have been in exhibitor's possession from seeds, cuttings or immature plants and grown to maturity. Bulbous blooms must have been in exhibitor's possession from planting of bulb, tuber, corm, rhizome or it must have been cared for as a mature plant at least 90 days.
3. Container-grown plants must have been in exhibitor's possession at least 90 days. Exceptions: Multiple and combination plantings must have been growing together and in exhibitor's possession at least six weeks.
4. All Horticulture entries must be received on Thursday, September 15, 2016 from 2-6 pm. Specimens such as Day Lilies and Hibiscus that have a single daily bloom may be entered on Friday, September 16, from 8-10 am. Pre-registration with Classification Chairmen, Pam Wright or Charlotte Spiers is required for Sections L and M by Friday, September 9, 2016.
5. All specimens should be correctly named, giving genus and species, with variety/cultivar added when appropriate. Common name may also be given. Only those properly named are eligible for National Garden Clubs, Inc. Top Exhibitor Awards.
6. Exhibitor may make more than one entry per class or subdivision if each is a different genus, species, variety, cultivar, type, size, or color.
7. Plant material may not be altered by the application (treatment) of oil, commercial "shine" products, etc. that may artificially change the natural color and texture.
8. Clear glass containers, plastic wrap and Styrofoam wedging material will be provided for cut specimens by Committee.
9. Cut specimens must have no foliage below the water line.
10. Cut specimens should be one stem and should not exceed 30" in length unless otherwise indicated in Section or Class requirements.
11. Maximum size of containers is indicated in the class description. The diameter, width or length of the container is measured from inside the lip.
12. All entry cards are to be filled out in advance in pencil or water-proof ink. Entry cards may be obtained from the Classification Chairmen.
13. The Classification Committee may add, delete or subdivide Classes, according to genus, species, variety, cultivar, type, size or color.
14. Entries will be placed by the Placement Committee.
15. Horticulture exhibits are to be judged by the applicable scales of points found on pages 298-302 of the NGC *Handbook for Flower Shows, 2007 rev. Edition.*

“Earth Day” - 1970s

CUT SPECIMENS, FOLIAGE PERENNIALS: 1 stem; **exception:** stemless grasses, 5 blades. All classes to be judged using the **Foliage Specimens Scale of Points.**

- Class 15. *Heuchera*
- Class 16. *Hosta*
- Class 17. Any Other Cut Foliage Perennial

SECTION D.

“Atomic Energy” - 1950s

Eligible for **Award of Merit**

CUT SPECIMENS, FOLIAGE ANNUALS: 1 stem All classes to be judged using the **Foliage Specimens Scale of Points.**

- Class 19. *Caladium*
- Class 20. *Plectranthus scutellarioides* (Coleus)
- Class 21. Any Other Cut Foliage Annual

SECTION E.

“Scarborough Fair” - 1960s

Eligible for **Award of Merit**

CUT SPECIMENS OF HERBS: 1 stem. All classes to be judged using the **Foliage Specimens Scale of Points.**

SECTION F.

"Woodstock" - 1960s

Eligible for **Arboreal Award**

DECIDUOUS TREE AND SHRUB BRANCHES: 1 branch, not to exceed 30" from cut end to tip; must include several nodes and apical tip. All classes to be judged using the **Arboreals: Foliage, Flowering, Fruited, Coned Scale of Points.**

EVERGREEN TREE AND SHRUB BRANCHES: 1 branch, not to exceed 30" from cut end to tip; must include several nodes and apical tip. All classes to be judged using the **Arboreals: Foliage, Flowering, Fruited, Coned Scale of Points.**

SECTION H.

“Victory Gardens” – 1940s

Eligible for **Award of Merit**

FRUITS, VEGETABLES AND NUTS: To be judged using the Fruits, Vegetables and Nuts Scale of Points.

- Class 31. *Brassica oleracea* (Cabbage Family)
- Class 32. *Capsicum annuum* (Pepper) – 1, 3, or 5 specimens depending on size, ¼”- ½” stem
- Class 33. *Curcubita* (Squash, Pumpkin family) – 1 specimen, stems trimmed to ½”- 3” in proportion to size of specimen
- Class 34. *Lycopersicon esculentum* (Tomato) – 1, 3, or 5 specimens depending on size, stems removed and stem side down for medium and large specimens, stems intact for small specimens
- Class 35. Root Crops – 1, 3, or 5 specimens depending on size, stems trimmed to 1”- 3”
- Class 36. Any Other Fruit, Nut or Vegetable – 1, 3 or 5 specimens depending on size

Container not to exceed 8” in diameter. All classes to be judged using the **Foliage Specimens Scale of Points.**

SECTION J.

“Barbie Dolls” – 1950s

CONTAINER-GROWN FLOWERING PLANTS: Container not to exceed 8” in diameter. All classes to be judged using the **Flowering Specimens Scale of Points.**

- Class 43. *Saintpaulia* (African Violet)
- Class 44. *Sinningia* (Gloxinia)
- Class 45. Any Other Container-grown Flowering Plant

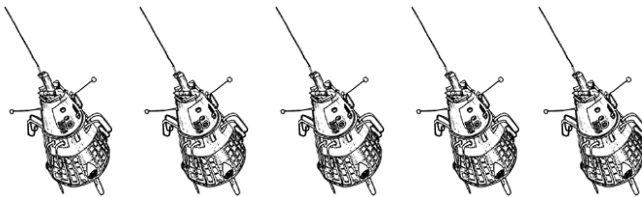
SECTION K.

“Sputnik” – 1960s

Eligible for **Grower’s Choice Award**

CONTAINER-GROWN FOLIAGE PLANTS: Container not to exceed 8” in diameter. All classes to be judged using the **Foliage Specimens Scale of Points.**

- Class 46. *Begonia*
- Class 47. Ferns (Not on the NY State Endangered List)
- Class 48. *Hedera helix* (Ivy)
- Class 49. *Philodendron*
- Class 50. Any Other Container -Grown Foliage Plant



SECTION L.

"United Nations" - 1940s

Eligible for **Grower's Choice Award**
Pre-registration required

COMBINATION PLANTINGS: Container not to exceed 15" in length, width, diameter or height containing three or more specimens of plants with compatible cultural requirements. To be judged using the **Combination Plantings Scale of Points**.

- Class 51. **Dish Garden:** A miniature landscape of different succulents in an open container. Accessories permitted.
- Class 52. **Planter:** A group of different plants grown together outdoors. Accessories are not permitted.
- Class 53. **Terrarium:** A miniature landscape of different specimens of indoor plants in a transparent container. Accessories permitted.
- Class 54. **Trough:** A miniature naturalistic landscape of different specimens in a container made to withstand year-round weather conditions. Naturalistic accessories such as rocks and weathered wood are permitted.

SECTION M.

"Zip Codes" - 1960s

Eligible for **Collector's Showcase Award**

DISPLAYS: A minimum of five different specimens exhibited independently. Artistic effect and cultural perfection are of equal importance. To be judged using the **Displays Scale of Points**.

Allowable space, 18" wide x 30" deep for each exhibit.

Pre-registration required

- Class 55. Display of cut specimens of herbs in transparent containers supplied by the exhibitor.
- Class 56. Display of separate container grown plants of the same family or genus. Containers are not to exceed 6" in width or diameter.
- Class 57. Display of cut specimens of evergreen branches.
- Class 58. Display of epiphytes (air plants) of the same genus.

DIVISION AWARD

**AWARD OF HORTICULTURAL EXCELLENCE - Rosette of Green,
Orange and Blue Ribbons**

One Award is offered to the highest scoring exhibit in the entire Horticulture Division entered by a single exhibitor, provided all General and Horticulture Award Requirements are met. Exhibit must be correctly named according to schedule specifications. In sections where Top Exhibitor Awards have been placed, only those winners are eligible for consideration from those sections for the Award of Horticultural Excellence.

SECTION AWARDS

General Requirements: Exhibit must be a blue ribbon winner, correctly named, scoring 95 or more in a section of at least three classes (no minimum number of exhibits required) as designated in the schedule providing all other General and Horticulture Award Requirements have been met. Judges must withhold awards if not merited.

ARBOREAL AWARD - Rosette of Green Ribbons in Two Shades

Two awards are offered and may be awarded in a section composed of cut tree and/or shrub branches. Section F., Classes 25-28 and Section G., Classes 29-33 are eligible.

AWARD OF MERIT - Rosette of Orange Ribbons

Five awards are offered and may be awarded to the highest scoring exhibits in Sections of cut, non-arboreal specimens. Section A., Classes 1-7; Section B., Classes 8-13; Section D., Classes 18-21; Section E., Classes 22-24 and Section H., Classes 34-39 are eligible.

GROWER'S CHOICE AWARD - Rosette of Dark Green Ribbons

Three awards are offered and may be awarded in a Section of container-grown plants sharing some common characteristic. Section I., Classes 37-41; Section K., Classes 46-50; Section L., Classes 51-54 are eligible.

COLLECTOR'S SHOWCASE AWARD - Rosette of Brown and Green Ribbons

One award is offered and may be awarded in a Section of container-grown plants sharing some common characteristic. Section M., Classes 55-58 are eligible.

HORTICULTURE DIVISION

MAY RATCHFORD HORTICULTURAL EXCELLENCE AWARD
Rosette of Purple, Lavender and White Ribbons

May be awarded to a 9th District Member for the most outstanding, correctly named horticulture exhibit in a 9th District Standard Flower Show which has won the NGC Award of Horticultural Excellence, if offered and awarded. It is accompanied by a Waterford crystal bowl which is to be held for one year and then returned to the 9th District Awards Chairman.

DIVISION III -SPECIAL EXHIBITS

Adult Educational Rules

1. All General Rules apply.
2. Entries will be received on Thursday, September 15, 2016 from 2-6 pm and on Friday, September 16, 2016 from 8-10 am.
3. An Adult Educational Exhibit may be the work of more than one exhibitor. However, it may not be used as an exhibiting credit by a Student or Accredited Judge unless it is the work of one exhibitor.
4. To be eligible for an NGC Top Exhibitor Award an Educational Exhibit must occupy a minimum of 18 square feet surface area.
5. Exhibits are judged using the National Garden Clubs, Inc. **Special Exhibits Scales of Points** (see below). For more information refer to page 304 of the NGC *Handbook for Flower Shows, 2007 rev. Edition*.

Youth Rules

1. All Youth Design exhibits must be created by one youth. Horticulture exhibits must be grown by one youth.
2. Juniors (Pre-school through age 7), Intermediate (Ages 8 through 12) and High School (Ages 13 through 18) are eligible to enter.
3. Entries will be received on Thursday, September 15, 2016 from 2-6 pm and on Friday, September 16, 2016 from 8-10 am.
4. Youth Educational Exhibits require a minimum of 6 square feet surface area and may be created by more than one youth.
5. Youth exhibitors must have had possession of container-grown plants for at least 60 days. Combination or multiple plants such as terrariums and dish gardens must have been growing together for at least 3 weeks.
6. Youth Design and Horticulture exhibits are judged by adult Scales of Points, but a score of only 90 or above is required to place a Youth Top Exhibitor Award. Refer to page 4 of schedule for Design Scale of Points. Horticulture exhibits are to be judged by the scales of points found on pages 298-302 of the NGC *Handbook for Flower Shows, 2007 rev. Edition*. See above for Educational Scale of Points.

Class 2. Succulent

A succulent pup or cutting "adopted" by exhibitor and named for a *Star Wars* character. Container is not to exceed 4" in diameter measured inside the lip.

Class 3. Dish Garden

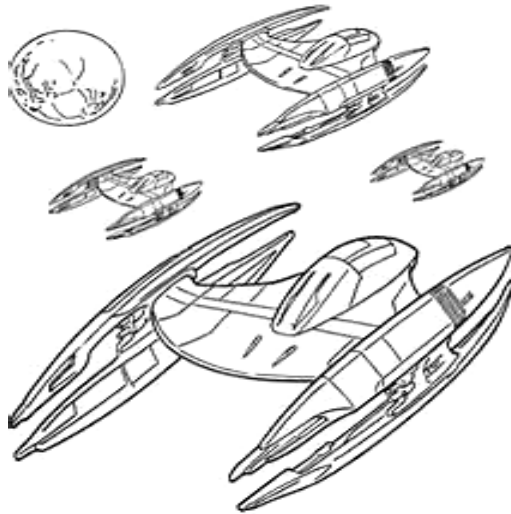
